

SPACEPORT CORNWALL PROMOTION TERMS AND CONDITIONS

FULL T&CS

INTRODUCTION

These terms and conditions govern your entry to participate in a prize draw for the chance to win a Spaceport Cornwall tour and a selection of runner-up prizes (the "**Promotion**").

By entering this Promotion, all participants will be deemed to have accepted these terms and conditions in full. All entry instructions form part of these terms and conditions. Please read these terms and conditions carefully. If you do not agree to all the terms and conditions, please do not enter the Promotion.

The Promotion is only open to participants who are:
members of the Virgin Red programme (to become a member of the Virgin Red programme participants must accept and comply with the terms and conditions of use which can be found [here](#));
residents of the UK; and
aged 18 or over at the date on which they enter the Promotion.

Employees of the Promoter (as defined below), Virgin Management Limited, Virgin Enterprises Limited, LeadFamily ApS, Virgin Orbit, LLC, Spaceport Cornwall, anyone professionally connected with this Promotion and any member of their respective immediate families may not participate in the Promotion.

The Promotion closes on 31.08.22 at 23:59pm (the "**Closing Date**"). No entries received after the Closing Date will be eligible to win.

HOW TO ENTER THE PROMOTION

To enter the Promotion, qualifying entrants must:
be or become a member of the Virgin Red programme and accept the [Programme Terms and Conditions](#);
tap on the "Win A Trip To Spaceport Cornwall" tile in the Virgin Red app or on the Virgin Red website;
follow the instructions on the tile and answer the question correctly to be entered into the prize draw.

Only one entry per member is permitted. No purchase necessary.

PRIZES AND WINNERS

The winners will be selected at random using an automated computer process from all eligible entries in the prize draw within 10 days of the Closing Date.

The first winner selected by the automated computer process will win the Main Prize described below and the next five winners selected will win the Runner-up Prizes (as defined below).

Main Prize:

- (a) The winner of the Main Prize will win:
 - (i) a private tour of Spaceport Cornwall for themselves and up to three guests;
 - (ii) a two night stay at a 3 star hotel in Cornwall for themselves and their three guests (sharing two hotel rooms); and
 - (ii) a surf lesson for themselves and their three guests during their stay (subject to weather conditions).
- (b) Food, drink and transport to and from Cornwall and during the stay are not included and will be the responsibility of the winner.
- (c) The estimated date of the Spaceport Cornwall tour will be notified to the winner as soon as possible following notification of their prize in accordance with clause 3.5 below. If the winner is unable to attend the tour on the specified date, the Promoter and/or Spaceport Cornwall will work with the winner to try to find a suitable alternative date (excluding school holidays). The tour must be taken by 15 December 2022.

Runner-up Prizes: Five winners will each win a goodie bag of merchandise from Spaceport Cornwall.

Each winner will be notified by email that they have won within 14 days of the Closing Date. The winner of the Main Prize will be provided with details of how to claim their prize, which will involve being contacted by and/or liaising directly with the company or companies providing the different elements of the prize to confirm applicable details. Winners of the Runner-up Prizes will be asked to provide a UK address for delivery, which will be deleted following delivery of the prize. Runner-up Prizes will be delivered by 31 September 2022.

If the Promoter is unable to contact a winner within three (3) working days, the Promoter is unable to verify a winner's eligibility to win a prize or a winner is not eligible to win a prize, the Promoter reserves the right to award the prize to an alternative winner selected at random in accordance with clause 3.2 of these terms and conditions and the prize will be forfeited by the original winner.

All costs and expenses not included within the prizes are the responsibility of the winners including, but not limited to, any additional costs, insurance and taxes.

CONDITIONS

We will have the final overall decision over the selection of the winners and this decision is final. No correspondence will be entered into, except with the winners.

There is no cash alternative available. The prizes are as stated and no alternatives are available. The prizes are non-transferable and cannot be resold. Unless otherwise agreed in writing by the Promoter, the prizes will only be awarded to the winners.

The Promoter reserves the right to publish or make available on request to membersupport@virgin.com, information that indicates that a valid award took place – for example, the surname and county of residence of the winners. Affected prize winners have the right to object to all or part of this information being published or made available – in such event please contact the Promoter at red.dpo@virgin.com. In such circumstances, entrants acknowledge that the Promoter must nevertheless still provide the information and winning entry to the Advertising Standards Authority or equivalent regulator on request.

Any personal data relating to the winners or any other entrants will be used solely in accordance with our Privacy Policy and current UK data protection legislation.

If you are a winner, we may also contact you (by email or telephone) to ask you to participate in promotional activities including, but not limited to, website articles and social media posts.

No entries from agents, third parties, syndicated entries or those made using methods such as a computer macro, script or the use of automated devices are permitted and no bulk entries permitted.

The Promoter reserves the right at any time, in its absolute discretion, to (i) verify the eligibility of any participant (including their age and place of residence); and (ii) disqualify any participant found to be abusing or tampering with the operation of the Promotion or entering using fraudulent means, or who the Promoter believes to have acted in breach of these terms and conditions.

GENERAL

The Promoter is not responsible for any loss or damage that is not foreseeable or that results from the failures of persons or systems that we do not directly control. However, nothing in these terms and conditions removes or limits our liability for: (a) fraud; or (b) death or personal injury caused by our negligence. These terms and conditions also do not affect the legal rights that are granted to you as a consumer.

The Promotion is not in any way sponsored, endorsed or administered by, or associated with any social media platform on which the prize draw may be promoted. Participants acknowledge that no such social media platform shall have any liability to them in connection with the Promotion.

The Promoter reserves the right to extend, withdraw, alter or suspend the Promotion or these terms and conditions, including the substitution of any prize or prizes, at any time if circumstances beyond its control make this unavoidable.

All personal data submitted in connection with the Promotion will be processed by the Promoter and its agent for the purposes of administering and managing the Promotion and prizes (where applicable) and verifying the eligibility of each participant.
